**Tournament Notes:** The May tournament and date has changed, May tournament will be held @ Choke Canyon on May 23<sup>rd</sup> & 24<sup>th</sup>, water levels are dangerously low at Mathis.

The tournament committee has agreed on using carbon copy weigh-in slips during tournament weigh-ins, the same as it is done at City Championship. This is to reduce the discrepancies on weights and allow the weigh master to relay weights to the tournament director clearly and correctly, each person will initial and receive a copy after each tournament. Members of the tournament committee will take turns helping fill out weigh-in slips at tournaments. Jenny Mergele also added that there should only be a 5 fish limit in each bag, it is hard to transfer 5 or more fish from one bag to another. With summer months ahead of us we need to keep these fish in the water and keep them alive as long as possible, especially larger fish.
